TRAIL AGREEMENT

Private golf carts may be used only by Plantation at Leesburg RESIDENTS who acquire and maintain a current membership, and who are in good standing ("Member"). The right to use private golf carts on The Plantation Golf Club grounds may also be obtained on an annual basis in accordance with the terms of this Agreement and the rules and policies as they may change from time to time. All trail fees are annual agreements. The trail fee is non-refundable. This right is non-transferable and nonassignable and may be canceled at any time at the discretion of management. Each Member is responsible for the use and or damage associated with their cart. Trail fee privileges are granted only for the benefit of the undersigned Member, the Member spouse, and dependents, living at home or attending school on a full-time basis, and having a valid driver's license. Private golf carts must be inspected and approved each year by the club as complying with the appearance and other standards as stated in this Agreement and the Rules and Regulations of The Plantation Golf Club, as the same may be amended from time to time. Anyone not a Member of the Member's immediate family living at home on a private cart with a Member is required to pay regular club cart and green fees.
